Winter Safety Tips

Experiencing one of the coldest winters in decades leaves us dealing with snow and ice. Whether you are in your home or business, there are safety precautions you can take to decrease the risks associated with this time of year.

Be sure you have shovels and salt or sand buckets ready for use. Try to keep several days supply on hand; in the case of a severe storm there could be shortages. Any gasoline in containers should be stored in UL list safety cans and stored in a cool, dry area away from open flames and other sources of ignition.

There are new calcium chloride pellets that are good for ice removal in extremely cold weather. They also do less damage to

concrete than normal rock salt. Keep in mind that snow melting during the day means ice at night. You may want to check driveways and walkways more than once a day.

We recommend you have secure rugs by your doors to pick up snow before it gets into the building and creates a slippery floor. Lights are also important in slip prevention, so make sure all sidewalk and driveway parking lot lights are in good working order.
